## 2. AGENDA BASHING

## **Report from Valencia Meeting**

IB: All input provided by us (annexes, requirement tables) has been well accepted and the presentations from the different work packages were well align with it. There are a number of technical questions that have been compiled in a google doc including the main topics of the discussions in Valencia:

IB will recollect all the questions and will address them in the WP2.







PS propose to use the INDIGO OpenProject instance (wp2) and track all the questions there. That methodology could be also added in the Deliverable D2.1. IB agreed with that. Users need to be registered to access:

From Valencia meeting we got also feedback regarding Data Management Plans. Our analysis is very weak due to the partial information from the different communities. It should be fixed for the next deliverable, as well as requirement input from INFRADEVs.

One of the main points in the slides is the proposal of a "Champion" in every research community to check that all requirements become real. We need to identify that person and involve her/him in an Agile interaction with JRA (how to do that?).

One of these INFRADEVs is Parthenos, where we have common partners, like RBI/DARIAH and ICCU. Last week the Kick-off meeting took place. One part of the project is related to VRE and data access. SdG will give us more details about it, and CNR coordinates the implementation.

JM: The next deliverable in December should include information of PARTHENOS, ENVRI+ and other INFRADEVs and VRE projects.

Regarding next EGI meeting in Bari, Should we as INDIGO WP2 send some input? The outcme of the analysis of requirements? We need to think what we should submit (Deadline is next 19<sup>th</sup> July).

#### Status Deliverable D2.1

PS: The deliverable is progressing well, most sections being completed.

The latest draft structure was shown: User Communities, Methodology, Case studies, Requirements (Tables).

Some of the communities have provided feedback to the requirements table. Notice also that the annexes are "live" documents that can be edited as required (taking care of versioning). They will have to be updated for the next deliverable.

Action: Check the collection of technical questions from WPs partners.

One of the main discussions in Valencia was regarding AAI. A questionnaire from AARC, a project where EGI.eu participates, has been circulated, asking for AAI input from research communities. PS who is







involved in the project will coordinate AARC input with AAI INDIGO task force. GD says that Marcus (one of the main persons in AAI task force in INDIGO) is also involved in AARC.

JM proposed to add in more detail the AAI issue in the next requirements gathering and deliverable.

D2.1 should be almost ready to be distributed on the weekend and then it will be sent to the PMB.

#### Plans for next weeks

All information like documents and so on will be migrated to OpenProject. We have to determine how to address the requirements feedback and interaction within OpenProject, but it could be managed with one ticket per requirement.

#### **Deliverable D2.2**

Eva Cetinic reported on the status and the outcome of the teleconf held the previous day with other actors in Dissemination and Outreach within INDIGO (Tust-IT, also EGI.eu). It is now clear that task 2.4 should address dissemination towards research communities.

Most of the communities have answered to the mail from Eva asking for information for the potential dissemination activities. Thus the point 4.4 from the deliverable regarding dissemination of all Research Communities is progressing quite well. Eva needs some more information from some communities yet and a reminder will be sent by e-mail as the deliverable should be finished by the end of next week.

Regarding the inclusion of the KPI table inputs, it has to be discussed by the PMB, so for now it won't be included in the deliverable. Jesus indicates that it can be used internally to track the expected progress.
